

Terms and conditions Tilburg Lacrosse Cup 2020

1. Register process

1.1 Teams who will not accept the terms and conditions as described underneath will be denied by the organization of the Tilburg Lacrosse Cup and cannot participate in the tournament.

1.2 The register form and the player list (per team) has to be filled in according to the truth and signed by the contact person of the team.

1.3 Signing up for the Tilburg Lacrosse Cup is done by sending an email to info@tilburglacrossecup.nl with the team name, Whether it's a male team or a female team, suspected amount of participants and the contact person. This has to be done within a month (latest 18th of march) of receiving the email with the invitation.

1.4 After signing up, the Tilburg Lacrosse Cup organization selects the teams that can participate in the Tilburg Lacrosse Cup. The selected teams will be notified before 21st of march.

1.5 To finish the registration the selected teams must send: the full names of all participants , shirt numbers of all participants, dietary wishes and the team fee. This has to be done within two weeks after the team is notified. (latest 4th of April)

1.6 After registering, extra players can only be subscribed through sending an email to info@tilburglacrossecup.nl, with the name of the team, the name of the person in question.

1.7 All participants must be **16** years or older.

1.8 A team need to consist of **at least 13** persons.

1.9 Subscription to the Tilburg Lacrosse Cup 2020 is official when the contact person, aside from the application by email has paid the team fee as describe under 2.1

1.10 All teams must adhere to the registering process of the terms and conditions. The organization will confirm all complete subscriptions.

2. Finance

2.1 The team fee for the Tilburg Lacrosse Cup is €750 (seven-hundred-fifty euro). This **includes** 15 participants. An additional €50 (fifty euro) needs to be paid for every extra participant.

2.2 the team fee is due 4th of April

2.3 If a team cancels between 4th of April and four weeks before the start of the Tilburg Lacrosse Cup, it can either fix a new team, who has paid the team fee, and receive the full team fee back or if they fail to find another team receive only 1/3 of the team fee back.

2.3 By cancelation of a team and/or person within four weeks of the start of the Tilburg Lacrosse Cup the fee will not be refunded.

2.4 By cancelation of the tournament the team fee will be refunded

2.5 The program of the tournament is proviso, by cancellation of some acts/games the team fee will not be restituted.

2.6 Food and drinks can only be bought with Were-Di coins, these coins are sold by the Tilburg Lacrosse Cup organization. The coins cannot be sold back to the organization.

3. Entry at the beginning of the tournament.

3.1 Teams that did not meet the terms and conditions will be denied entry of fields and cannot participate in the tournament

3.2 By entry everybody will be checked if they are above 16 years old. Participants who cannot show valid Identification may not participate in the tournament.

3.3 Everybody will receive a bracelet to show that they are participants of this tournament. These bracelets will only be given to registered participants. When the bracelet is lost a new one can be provided by the organization for a small fee.

4. Terms of conduct

4.1 Participants of the Tilburg Lacrosse cup are obliged to show their Identification at any given moment.

4.2 Participants are obliged to wear their Tilburg Lacrosse Cup bracelet during the tournament. Only person with a valid bracelet, and thus a valid subscription, are allowed on the property of H.C. Were Di

4.3 It is strictly forbidden to smoke or bring glass objects on the fields of H.C. Were Di

4.4 Damaging the building of H.C. Were Di, or any of the fields is strictly forbidden.

4.5 The usage, possession or distribution of any type of soft and/or hard drugs (this includes Marijuana.) is forbidden on the property of H.C. Were Di. The Police will be notified.

4.6 The usage, possession or distribution of any type of weapon is forbidden on the property of H.C. Were Di. The police will be notified

4.7 Open fires and barbecues are forbidden. On the property there will be fire-extinguishers, only to be used in case of fire. Abuse of the fire-extinguishers is forbidden. The abuser is liable for any type of damages relating to the usage of the fire-extinguisher.

4.8 It is not allowed to bring any type of alcohol to the event.

4.9 Alcohol is only sold to persons who are **18 years** or older, a valid ID may be asked when purchasing alcohol.

4.10 The usage of personal stereo equipment is not allowed on the property of H.C. Were Di.

4.11 Cars must stay outside of the fence and can be placed on the parking lot of H.C. Were Di. H.C. Were Di and the organization are not responsible or liable for any damages on the cars whether they were in the parking lot or on the street.

4.12 Caravans, Campers or trucks are not allowed on the property of H.C. were Di. They **cannot** be placed on the parking lot. People can only camp in tents who can be placed on the property of H.C. Were Di.

4.13 Bikes can only be placed on the designated spots. This in connection with the free passage of the emergency services.

4.14 The house rules of H.C. Were Di must be respected.

5. Lacrosse Rules

5.1 During the games of the Tilburg Lacrosse Cup female players are obliged to wear, mouthguard, team shirt with a number on the front and on the back and shoes.

5.2 During the games of Tilburg Lacrosse Cup we, the organization, recommend also wearing goggles.

5.3 During the games of Tilburg Lacrosse Cup male players are obliged to wear gloves, a helmet, a shirt with a number on the front and on the back and shoes.

- 5.4 During the games of Tilburg Lacrosse Cup we, the organization, recommend also wearing, mouth guard, arms pads, chest protectors, shoulder pads, rib pads and or jocks.
- 5.5 On the beginning of every game the assigned referee will check whether everyone wears the obliged equipment.
- 5.6 By failure of wearing the obliged equipment the organization can deny the player access to any further games of the Tilburg Lacrosse Cup 2020.
- 5.7 Not wearing the obliged or recommended items is at one's own risk. The organization is not liable for damage resulting in failure to wear the obliged or recommended equipment.
- 5.8 The organization of Tilburg Lacrosse Cup is not liable for any damages to the person or property resulting from participating in the games of Tilburg Lacrosse Cup 2020
- 5.9 The rules of the **FIL** are used during the games of Tilburg Lacrosse Cup 2020

6. Liability

- 6.1 This event is held in the Netherlands and therefore is covered under **Dutch law**. The assigned court will be **the Dutch court in Breda**.
- 6.2 Persons who cause any type of damages are liable for the cost of those damage. The organization of The Tilburg Lacrosse Cup will claim the damages upon the perpetrator(s), if this is unknown the whole team will be liable and if he team is unknown all who were present are liable unless they can prove otherwise.
- 6.3 The organization of the Tilburg Lacrosse Cup is not liable for any type of damages to the person or property during these events.
- 6.3 The organization of the Tilburg Lacrosse Cup has the right to film or document all participants of the Tilburg Lacrosse Cup, or anyone who is on the property of H.C. Were di during this event. Photographs of the tournament will be published on the Facebook of the Tilburg lacrosse Cup. The Organization will hold the copyright to any picture taken at the tournament. Films and or photographs can be shared with the Dutch police.
- 6.4 The organization of Tilburg Lacrosse Cup has the right to at any time deny any participant who violate the terms and conditions or misbehaves, without being liable.

7. Authorization of the organization of Tilburg Lacrosse Cup

- 7.1 During the whole tournament everyone is obliged to follow any instructions given by the organization, security services and/or the emergency services.
- 7.2 Person(s) or team(s) who are aggressive, show other type of odd behavior, or violate these terms and conditions can be, in consultation with the security services and/or the organization, denied access to the property and will be excluded of further participation of the tournament.
- 7.3 In case of suspicion of possession of drugs and/or weapons the security services and/or the organization is allowed to search Tents and conduct pat-downs on the suspected individuals.
- 7.4 The in the terms and conditions forbidden items will be seized. Only the stereo installations will be returned to the teams at the end of the tournament.
- 7.5 The organization, security services and/or emergency services have the right and the obligation to ask for the Identification of a person if he is suspected of anything mentioned in 4. terms of conduct

7.8 the terms and conditions may be altered. Teams will be notified over email in due time.

8. Additional terms third parties

8.1 During the Tilburg Lacrosse Cup third parties may be present to make pictures. These pictures are made for personal or commercial purposes. By acceptance these terms and conditions the team agrees with being photographed and the publication of the pictures.

9. Statement of approval

9.1 By registering for the Tilburg Lacrosse Cup the whole team automatically accept the terms and conditions valid for the Tilburg Lacrosse Cup 2020.
